May 12th, 2022

The Board of Trustees of the Boston Groundwater Trust met in the Heritage Room at the Lenox Hotel located at 710 Boylston Street, Boston, MA. 1. Adoption of March 23rd, 2022, Board Meeting Minutes

Mr. Whitney and Mr. Simonelli reviewed the Trust's financials. Discussion followed Mr. Simonelli reviewed the proposed FY23 budget. Mr. Simonelli stated that he drafted and reviewed a funding increase letter with co-chairs Whitney & Saunders. That letter was finalized and sent to City Councilor Kenzie Bok. Discussion followed.

3. <u>City Legal Representation Update</u>

Mr. Simonelli stated that he continues to work with the City of Boston's law department regarding implementation of the ordinance passed by the City Council, which provides for legal representation by the City for the Trust. Discussion followed.

4. Map Upgrade Update

Mr. Simonelli reviewed the progress made with representatives from Environmental Systems Research Institute, Inc. (ESRI) on the map upgrade. He outlined the new data-collection method for manual observation well readings, and the new public-facing observation well and building foundation data map. Discussion followed.

5. 2022 City-Wide Groundwater Forum Update

Mr. Simonelli reviewed a draft outline for the forum. Discussion followed. Mr. Simonelli will work with Mr. Whitney and other Trustees on revising the outline, selecting speakers, and establishing groups for the forum. Discussion followed. EXECUTIVE DIRECTOR'S REPORT May 12th, 2022

1. **Readings** - Completed our second set of readings of 2022 and revamp of our data collection methods for readings. Started our third set of readings last week.

2. Meetings and Calls -

- a. Virtually participated in the 10th Annual Massachusetts Water Forum: Making the Invisible Visible (3/24)
- b. Wrote comment letter for 80 East Berkeley Street Project in the South End. (3/28)
- c. Microsoft Teams met with representatives from Environmental Systems Research Institute (ESRI) for working sessions and knowledge transfer for map upgrade. (3/31, 4/5, 4/14, 4/22, & 4/28)
- d. Along with co-chairs Saunders and Whitney I Google met with the City's Environment Chief Mariama White-Hammond and Environment Commissioner Dr. Alison Brizius. (4/6)

- m. Attended the BWSC commission April meeting via Zoom. (5/6)
- n. Testified via Zoom Zoning Board of Appeals hearings in March, April & May.
- o. Communicated with residents, engineers, attorneys, & developers throughout the GCOD to discuss ZBA procedures and advised them on what they need to submit to meet the GCOD zoning.
- BluCloud Remote Monitoring Solution The 5 new units have been transmitting readings daily since the beginning of March. The plan moving forward is evaluate the performance of these units over the next six months.
- 4. **BWSC** An update on the following:
 - BWSC is in the process of designing repairs to address the spots where groundwater infiltration has been observed in the North End, Back Bay, and the South End.
 - In Lower Beacon Hill, investigations continue at Brimmer and Beacon Streets. Catch basins were cleaned and no signs of infiltration were observed.
 - Back Bay
 - The contract has been awarded and construction is set for this Spring to repair a deep CSO on Fairfield Street, in the Beacon -Back Street block.
 - At Exeter and Boylston Street, a low spot is still being investigated where seepage was
 observed in an adjacent manhole. Additional video investigations showed no additional signs in other infrastructure. Investigations continue.

- Low area along Beacon St., Fairfield-Hereford St. blocks, is scheduled to be televised this Spring.
- Repairs for the Blagden Street sewer and laterals are currently in design phase.
- In the South End, investigations at a low spot along Harrison Avenue, in the East Concord Street Worcester Square blocks, revealed groundwater infiltration in an adjacent manhole.
- In the Fenway a low area along Hemenway Street was investigated and a 24" drain line in alley 807 revealed minor infiltration. Waiting on additional video from contractor to review.
- 5. MBTA Approximately 37gpm is being injected into recharge wells in the South End Ellis Neighborhood area along Appleton, Berkeley, Saint Charles, Cazenove, and Clarendon Streets. In addition to our manual monitoring, we have 4 wells in the area with dataloggers recording a water level every 60 min. MBTA and their consultant will review the viability of reducing flow in some of the systems in effort to maintain operational costs.
- 6. **DCR** Storrow Drive Tunnel Pump Station, recharge galleys, and flood control pumps working without any issues.
- 7. MWRA Continue working with BWSC on sewer separation and CSO improvements in East Boston.
- 8. **DOT** Cleaning and lining of the Prudential tunnel eastbound stormwater drainage system is scheduled to occur this Spring. Plan to inspect infrastructure in the vicinity of the former 1000 Boylston St. project in the Back Bay/Fenway.
